LOCATION

The industrial estate is located on Sandwell Business Park, off Crystal Drive, in the Smethwick area of Birmingham. Crystal Drive connects directly to the A4254 Telford Way/Kendrick Way.

Motorway access is provided at Junction 1 of the M5 less than two miles to the north east.

West Bromwich town centre lies approximately 1½ miles to the north and Birmingham city centre approximately 6 miles to the east.

DESCRIPTION

The property comprises an industrial/ warehouse unit with offices and staff facilities. The property is of steel portal frame construction with block infill underneath a lined pitched roof with suspended strip lighting.

The warehouse is accessed via electric roller shutter door (height 5.04m x width 3.69m) and offers an approximate eaves height of 5.36 metres rising to approximately 7.10 metres at the apex. The property also benefits from a three phase electrical supply.

To the front and side of the unit there is a dedicated car park/yard area.
